

Release of Liability and Assumption of Risk Agreement

In order to fairly and honestly inform you of the service we provide, you should know and appreciate that during your participation on a trip provided by **Unlimited Rivers Inc dba Rivers Inc**, certain specific risks and dangers exist which are inherent in river running and whitewater activities. These risks include, but are not limited to, loss of or damage to personal property, injury or fatality due to the capsize of a raft, collision with a vehicle, boat, other participants, rock, log or tree, immersion in water and hypothermia, falling while aboard a vessel or on shore, accident or illness in remote places without medical facilities, water damage due to leaking bags or other container, and exposure to temperature extremes and inclement weather.

I, the undersigned, hereby acknowledge that I understand that there are inherent risks in river trips, transportation to and from the river, as well as recreational activities (hiking, swimming, etc.) that are associated with this kind of river activity. These risks are impossible to eliminate by even the most prudent and careful planning and conduct on the part of the officers, agents, employees, owner and directors of **Rivers Inc**. *Participation in these activities entails unavoidable risks of loss of life, personal injury, illness, loss of consortium, and loss or damage to personal property.*

I understand that I am to be financially responsible for any medical treatment and any necessary emergency evacuation resulting from participation in the activities offered by **Rivers Inc**. I expressly covenant and state that I (or my minor child) am physically capable of engaging in these activities and accept and assume all risks in said activities for myself (and my minor child). My participation in this activity is purely voluntary, and I elect to participate in spite of the risks.

I specifically release and agree to indemnify and hold harmless **Rivers Inc**, its officers, agents, employees, owners and directors from any and all liability as to any right, action or claim to relief, including gross negligence, that may accrue to me or to my heirs or personal property which I may suffer while participating in the activity, transportation to and from the river, or any other recreational activities that may occur related to this activity. The terms hereof shall serve as a release and express assumption of risk for myself, my heirs, executors, and administrators and for all member of my family, including any minors accompanying me.

I understand that other participants, professional photographers, or **Rivers Inc** may wish to make photographs or video records of these activities for personal or promotional purposes, and I hereby grant permission for them to do so without recourse and without compensation to me.

I am of sound mind and am undertaking this activity of my own free will for myself and any minor children I am responsible for, and by signing this statement I take full responsibility for my own (and any minor children's) welfare, waive all future claims, and forever discharge and agree to indemnify and hold harmless **Rivers Inc**. **I have had sufficient opportunity to read this entire document. I have read and understood it, and I agree to be bound by its terms.**
